General Information & Provisions:

- Electronic punching system: SPORTident Air+ (range ~30cm)
 Owners of SI chips are asked to provide their SI card number when registering. Rental chips will be available in the competition center (rental fee € 2,-, security deposit € 30,-).
- The event is carried out in accordance with the competition rules of the Austrian Orienteering Federation. For the classes D21-E and H21-E the Competition Rules for IOF Foot Orienteering Events apply in addition, and supersede the national rules where applicable.
- The Austrian Orienteering Federation and the organizing clubs assume no liability for any damages that occur, including those to third parties. All participants take part at their own risk.
- The competition area is embargoed until the competition. Public roads are excepted from the embargo.
- Traffic, forestry and nature conservation laws apply.
- In case of cancellation of the event, neither the Austrian Orienteering Federation nor the organizing clubs assume any liability for costs incurred.
- On Saturday 05.10.2024, between 16 17 there will be a Trail-OL ca. 2,5 Km away from CC (you can go by car, cycle or feet). There will be an own registration on ANNE.

Anti-Doping

By participating in the event, all athletes agree to comply with the anti-doping regulations of the Austrian Federal Anti-Doping Act 2021 as well as the relevant regulations of the responsible national and international sports associations (in particular the statutes and competition rules). An athlete is defined as a person who is a member or licensee of a sports organization or an affiliated organization or who was a member at the time of a potential anti-doping rule violation, or who takes part in competitions organized by a sports organization or an affiliated organization supported by federal sports funding. If it is necessary for a participating athlete to take prohibited substances or use prohibited methods following a medical or dental diagnosis, athletes in the test pool must apply for a medical exemption in advance. All other athletes are also strongly recommended to keep all medical certificates and findings for any retroactive medical exemption. Data Protection

Use of personal data

This data is needed in order to provide the contractual services, without which this is not possible. The data is processed for the duration of the contract fulfillment or legal retention obligations. The data will only be passed on to third parties for the purpose of fulfilling contractual or legal obligations. You have the right to information, correction, deletion, objection and data transfer as well as the right to complain to the responsible data protection authority (at www.dsb.gv.at). You also have the right to revoke your consent at any time, although despite your revocation, data processing may still be permitted based on other legal grounds. Appropriate technical and organizational measures have been taken to protect your personal data.

This applies in particular also to the use of these materials for (including commercial) advertising purposes by us as those responsible, of whatever kind and in whatever (image and sound) format, for example the club's own homepage, published (media) reports or other printed works or media (including in electronic form or in social media) or advertising.
